

2013 Asian/Pacific American Heritage Association Photo Contest Rules

SPONSOR

The Sponsor is The Asian/Pacific American Heritage Association Organization (APAHA).

TERM

The 2013 Asian/Pacific American Heritage Association Photo Contest begins May 18, 2013 at 10am Central and ends with the submission of the photos at midnight June 1, 2013.

WHO MAY ENTER

The Contest is open to all residents of Houston and its vicinities.

HOW TO ENTER

Each Entry consists of an entry form, and a single image.

There is no entry fee. There is no limit on the number of entries per person.

To enter, visit www.apaha.org and complete an entry form with the required information, including your name, address, telephone number, email address, and photo caption. Photographs can be submitted in both digital and print form.

- Photographs can be in color or black & white. Digital photographs can be emailed to apaha2013@gmail.com. 11X14 print photographs can be submitted at the APAHA office.
- Digital files must be 5 megabytes or smaller, must be in JPEG or JPG format, and must be at least 1,600 pixels wide (if a horizontal image) or 1,600 pixels tall (if a vertical image).
- Photographs must be taken at the 2013 APAHA Festival.
- Watermarks are not acceptable.
- A caption is required. It should convey the circumstances in which the photograph was taken.

By entering the Contest, entrant acknowledges that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.

The entries in each Category will be judged separately. All entries must be submitted and received by June 1st, 2013.

RELEASES

Each entrant must sign the release form to grant APAHA the rights use the photos in a lawful manner to further its mission.

The submitted work will become property of APAHA and will not be returned.

CONTEST PRIZES

The First Place winner in each Category will receive US\$100.

The Second Place winner in each Category will receive US\$50.

The Third Place winner in each Category will receive \$25.

All winning photographs will be displayed at the Art Institute of Houston June 10th through July 11th.

JUDGING

The panel will consist of at least 3 judges.

LICENSE

By entering the Contest, all entrants grant an irrevocable, perpetual, worldwide non-exclusive license to Asian/Pacific American Heritage Association to reproduce, distribute, display and create derivative works of the entries (along with a name credit) in connection with the Contest and promotion of the Contest, in any media now or hereafter known.

LIMITATION OF LIABILITY

By entering this Contest, all entrants agree to release, discharge, and hold harmless Asian/Pacific American Heritage Association and its partners, affiliates, subsidiaries, advertising agencies, agents and their employees, officers, directors, and representatives from any claims, losses, and damages arising out of their participation in this Contest.

Entrants are responsible for complying with the Official Rules stated above. The winners' names will be available online at www.apaha.org after June 10, 2013.

DATA PRIVACY

Personal data will be used by Sponsor and its affiliates exclusively for the purposes stated herein.
